FY 2020 Coordinated Tribal Assistance Solicitation (CTAS) – This solicitation provides federally recognized tribes and tribal consortia an opportunity to apply for funding to aid in developing a comprehensive and coordinated approach to public safety and

victimization. The majority of DOJ's existing Tribal Government–specific programs are included in and available through this single Coordinated Tribal Assistance Solicitation. Each purpose area may have different eligibility requirements. For more information, please review the eligibility information under each purpose area section. 1) Federally recognized Indian tribes. 2) Consortia consisting of two or more federally recognized Indian tribes. 3) Tribal designees are eligible applicants only for certain activities related to the DOJ's Office on Violence Against Women (OVW) and Office for Victims of Crime (OVC) programs (see eligibility information for CTAS Purpose Areas 5 and 6, respectively). Current Closing Date for Applications: February 25, 2020.

OVC FY 2020 Housing Assistance Grants for Victims of Human Trafficking — The program will support the following types of housing assistance for victims of all forms of human trafficking: (1) transitional housing, including funding for the operating expenses of a newly developed or existing transitional housing program; (2) short-term housing assistance, including rental or utilities payment assistance and assistance with related expenses. Projects must also include support services designed to enable victims of human trafficking and any dependents to locate and secure permanent housing and find employment. OVC will conduct a pre-application

<u>Victim Service Providers in the United States, 2017</u> – This <u>report</u> provides statistics from the National Census of Victim Service Providers (VSPs), the first national data collection on the number and characteristics of these organizations. The census was conducted by BJS with support from the Office for Victims of Crime. The report describes the types of organizations that served victims, maps their locations, and reports on the rate of VSPs per 100,000 U.S. residents by state.

<u>Tools for Addressing Gender Bias in Sexual Assault Response Webinar</u> – In this brief 30-minute <u>webinar</u>, End Violence Against Women International (EVAWI) will offer a tour of these resources to help identify the presence of gender bias, mitigate its influence, and address key questions about how bias can disadvantage (or advantage) the victim and/or suspect.



Becoming a Trauma-Informed Court Reference Guide — A trauma-informed court is one that approaches court-involved individuals from a perspective of "what happened to you?" instead of "what is wrong with you?" and does so to create a more healing approach to the environment, policy and practice. Most families that come into court with child welfare cases are in crisis, therefore courts could be considered "socio-legal emergency rooms." By approaching the view of the court this way, stakeholders can prevent re-triggering and re-traumatizing families.

Through a public health approach, the <u>SOAR for Native Communities online module</u> helps those serving indigenous populations to better understand human trafficking and its impact on Native communities. The training includes resources relevant to indigenous populations and supports professionals in building trauma-informed and culturally responsive interventions to human trafficking in American Indian, Alaska Native, Native Hawaiian, and Pacific Islander communities.

SOAR Online is a series of training modules that can be completed anytime, anywhere. Because individuals who have experienced trafficking or who are at risk of trafficking access a variety of services, SOAR Online includes training tailored for specific professionals on how to identify and respond to human trafficking.
