#### OVC FY 2020 Developing Future Victim Specialists to Serve American Indian/Alaska Native Victims of Crime solicitation

OVC is seeking applicants for the FY 2020 Developing Future Victim Specialists to Serve American Indian/Alaska Native Victims of Crime solicitation. This program will develop a workforce of direct victim service providers to American Indian and Alaska Native victims in hard-to-staff positions and locations. By identifying and training prospective victim service professionals in, or from, the communities to be served, tribal and Bureau of Indian Affairs' victim service programs will be better able to fill direct victim service positions in remote Indian Country and Alaska Native locations, and in turn ensure that victims in these locations get the services they need. OVC anticipates that it will make awards under two purpose areas, as follows: Purpose Area 1—Recruiting Interns/Residents to Serve Tribal Victims in the Continental United States. Purpose Area 2—Recruiting Interns/Residents to Serve Tribal Victims in Alaska. OVC anticipates making up to 8 awards of up to \$450,000 each for a 36-month period of performance. Apply by May 26, 2020.



# OVC FY 2020 VOCA Victim Compensation Fellow

This program will support one fellow at OVC housed within the State Compensation and Assistance Division (SCAD). The individual awarded funding under this program will enhance the efforts of OVC to meet the needs of the crime victim services field by advising OVC on the development and oversight of programs for crime victims, specifically the VOCA Victim Compensation Program. The SCAD Fellow will work with Compensation Administrators to identify what OVC can do to better support states in the administration of state victim compensation programs. OVC anticipates making one award of up to \$400,000 for a 24-month period of performance, to begin on October 1, 2020. OVC will conduct a pre-application webinar on March 31, 2020, from 3:00 p.m. to 4:00 ET. Register and apply by May 18, 2020.

### Alaska Training and Technical Assistance Funding Opportunity: Denali Commission in partnership with OVC

The Denali Commission is partnering with the U.S. Department of Justice, Office for Victims of Crime (OVC) to administer a \$7 million program to assist victims of crime located in tribal areas of the state. As part of this three-year project the Denali Commission will assist Alaskan Tribes through capacity building and technical assistance with the vast majority of the funds set-aside for grants to communities and entities to provide crucial victim services. The AK TTA will support communities from conception to micro-grant implementation in a culturally informed approach. The AK TTA will provide technical assistance for the administrative reporting to the Commission as well as the Department of Justice's Performance Measurement Tools including the Subgrant Award Report, Subgrantee Performance Measures Report, and Grantee report. The AK TTA will collect, summarize, and develop reports summarizing services provided. In addition, the AK TTA will compile year-end and grant-end reports documenting the training and technical assistance provided as well as micro-grantee successes for use by the Commission and DOJ. ### Fraud Alert: Scammers Claiming to be with OVC

The Office for Victims of Crime (OVC) has received multiple reports that our office's name is being used as part of an imposter scam targeting individuals throughout the country. OVC is not making these phone calls. These scammers falsely represent themselves as OVC employees and attempt to obtain or confirm personal information from the call recipient, such as a social security number, or will ask for money by suggesting the person's social security number has been compromised. The scammers may call from a local number and provide a "case number," but it is all a fraud. OVC encourages the public to remain vigilant and do not provide personal information during calls in which someone claims to be from OVC or the "OVC Fraud Prevention Unit." OVC has no such unit.



## **Tribes Secure Funding in COVID-19 Relief Bill**

Congress passed and the President signed into law H.R. 748, a national stimulus package designed to address the far-reaching impacts of the coronavirus (COVID-19) pandemic. Over the past several weeks, the National Congress of American Indians (NCAI), tribal nations, partner organizations, and tribal advocates worked tirelessly to develop Indian Country's top policy priorities for addressing COVID-19 and push Congress to include these priorities in its stimulus package. The final legislation features strong provisions in support of these priorities and will help tribal communities across Indian Country as they respond to the pandemic. NCAI extends its deepest gratitude to the members of Congress who fought for the inclusion of Indian Country's priorities in the final legislation. The passage of this bill represents the first of several necessary steps that the federal government must take to ensure tribal nations, communities, organizations, and citizens have the resources they need to combat and recover from the COVID-19 pandemic.

### International Association of Chiefs of Police (IACP) COVID-19 Resources for Law Enforcement

Tribal Responses to Drug Overdoses—The Tribal Responses to Drug Overdoses solicitation is designed to assist federally recognized tribes in identifying resource deployment strategies to reduce the morbidity and mortality associated with drug overdoses among individuals who come in contact with law enforcement or are involved in the criminal justice system. Tribes will have the implementation support from the combined resources and expertise of the U.S. Department of Justice, Bureau of Justice Assistance (BJA), and the U.S. Department of Health and Human Services, Centers for Disease Control and Prevention (CDC), along with other partners. This solicitation is part of a series of solicitations to support national demonstration collaborations to build local capacity and support innovation. <u>The Tribal Resource Tool-</u> A searchable directory of all services available for Al/AN survivors of crime and abuse in Indian Country. Unfortunately, no segment of our society is immune to crime and violence. American Indians and Alaska Natives (Al/AN) have the highest crime victimization rates in the nation but often have difficulty connecting with the services that exist to help victims and survivors recover from crime and abuse. Fortunately, that is changing with the <u>Tribal Resource Tool</u>, a web-based resource mapping tool created to: provide a listing of all services available for Al/AN victims and survivors of crime and abuse and identify gaps in victim services so those can be addressed. Elder Fraud Hotline- For too long and far too frequently, fraudsters have preyed upon our senior citizens, robbing them of their hard-earned savings. To help combat fraud against older Americans, the U.S. Department of Justice launched the National Elder Fraud Hotline, managed by OVC, to provide services to adults ages 60 and older who may be victims of financial fraud. <u>StrongHearts Native Helpline-</u> The StrongHearts Native Helpline: 1-844-7NATIVE (762-8483) is a safe domestic violence and dating violence helpline for American Indians and Alaska Natives, offering culturally-appropriate <u>support</u> and advocacy daily from 7 a.m. to 10 p.m. CT. Anonymous and confidential.

<u>Talking to Your Children About Domestic Violence-</u> If your child is witnessing abuse in your home, what you're experiencing is likely made even worse by the concern you feel for your child. Children who live in



homes where abuse occurs – whether the abuse is emotional, verbal, physical or some other form – are very likely to be psychologically and emotionally affected by what they see and hear.\_The Children's Bureau's information service, Child Welfare Information Gateway, offers a number of publications related to preventing child abuse, protecting children from the risk of abuse, and promoting healthy families. NNEDV's 14th Annual Domestic Violence Counts Report - illuminates ongoing gaps in services and need for policy changes.

NNEDV began conducting the Domestic Violence Counts one-day survey fourteen years ago in order to provide accurate information about how many survivors seek support from domestic violence programs, without compromising survivors' safety or confidentiality. It is the only one-day unduplicated count of domestic violence services requested by adults and children across the United States in a 24-hour period. Year after year, state and local advocates, national experts, journalists and reporters, and policymakers from both sides of the aisle rely on the Domestic Violence Counts Report as a trusted source of data about the realities faced by advocates and survivors every day. 



